**WHEN:** Saturday, March 11, 2023

**WHERE:** Art Hauser Centre, 590 Gary Anderson Way, Prince Albert, SK

### MEET FORMAT and DISTANCES:

- ♦ **Junior, Neo Senior and Master Skaters** will skate on the 111.12m track. They will skate heats and finals 500m, 1000m and super final 1500m. **500m seed time required.**
- ♦ **T2T skaters** (M 12-15, F 11-14) will skate on a 100m track. Skaters will be ranked by ability. Their distances are heats and finals 200m, 400m and super final 1500m. **400m seed time required.**
- ♦ **L2T** (M 10-12, F 9-11) and **Fundamental** (M6-9, F 6-8) will skate on a 100m track. They will skate heats and finals 200m, 400m and super final 800m/1000m. Skaters will be ranked by ability. **300m seed time required.**
- ♦ **Active start** (less than 6 years) will skate a 50m and 100m on the 100m track.

AWARDS: Medals will be awarded to top 3 Males and Females in each group.

## RELEASE, WAIVER AND ASSUMPTION OF RISK

(b) That I freely and voluntarily assume all the aforesaid risks and hazards and my preparation for and participation in this event is entirely at my own risk;

(c) That I understand that neither the SSC, SASSA nor the said affiliate nor any members, officers, directors, employees, volunteers, servants, independent contractors, representatives and agents of the SSC, SASSA and the said affiliate assume any responsibility whatsoever for my safety during the course of my preparation for or participation in this event;

### PARENT ACKNOWLEDGEMENT, RELEASE AND AGREEMENT TO INDEMNIFY
